1) Call to Order

- a) Call to order 7:05
- b) June 2, 2022 minutes approved

2) Reports

- a) Treasurer's report read by Michelle (forwarded Chris' email)
 - Chrissy Gallo's Yoga and Forest bathing classes discussed. Chrissy is certified and is a contracted instructor with the county. Proceeds from the class fees will go to FHBB at Chrissy's discretion.
 - First Aid class will need to be fronted up to \$2100 (\$185pp, limit 14). Money reimbursed after RecDesk process fees
 - Dawn continuing to work on getting the FHBB's money from the Egg Hunt, about \$1000 still due from RecDesk (she's making progress!)
 - Money for camp t-shirts, a check has been cut to Dawn, to be delivered next week
 - Debit cards are now functional
- b) Social Media

 - Chrissy Gallos to join Social media team in September
 - Looking for someone to help with a newsletter
- c) Park and Nature Center Operations
 - Parking and road paving finished
 - Walkway across median to connect pavilion and nature center almost complete
 - Survey being done for pavilion
 - Need new restricted access signs
 - Summer residential camp and day camp are up and running
 - Animal care covered by volunteers, desk coverage also filled with volunteers most days
 - Nature center had a leaky pipe in the wall and a small flood in the exhibit hall- fixed by facilities

3) Projects

- a) Gardens
 - July 16 or 17, 8am, next garden event to tackle pond area and groundhog
 - Sign made for tribute garden- need Brad's approval
- b) Trails
 - Will pick up Share the Trail signs soon
 - Incorrect trail markers yet again appear in equestrian area trails
 - Concerns about heavy spraying with Round Up near streams- NOT the County

- Recent bike event went well, looking into a Minority Bikers event
- Jason mentioned Meet Up app used on MORE site to advertise events, suggested use for FHBB, Maggie will look into it
- New trail project being planned on Switchback trail in Union Mills side, perhaps mid August for another trail work day

4) Events

- a) Monarch Festival Planning
 - County has several activities planned and food covered
 - Face painting, butterfly tagging, animal ambassadors, crafts, games, planting for pollinators talk

 - Jason suggested (and offered to contact) McDaniel College ArtClub to help with face painting
- b) Run for the Raptors
 - On June 12th, Michelle and Nicole met with Brian Gardiner, an avid runner in the area, who offered to
 organize and promote this event, along with other possible 5k events.
 - Date is Oct 1st at 9 am. Sign-in is at 8:30 am. Cost is \$35 for 5K, \$25 for 2K
 - T-shirts being offered for 1st 50 registered (keep shirts under \$25)
 - Food and snacks planned, volunteers needed along route
 - Need to find sponsors
 - Will be added to the County Fall Guide
- c) Duck Hunt
 - Details in the works, don't plan on soliciting for big family prizes until September
 - Will be added to the County Fall Guide
